

#### Children of a Parent Living in a Same-Gender Relationship

A natural or adopted child of a parent living in a same-gender relationship, whether the couple is married or cohabiting, may not receive a name and a blessing.


A natural or adopted child of a parent living in a same-gender relationship, whether the couple is married or cohabiting, may be baptized and confirmed, ordained, or recommended for missionary service <u>only</u> as follows:

A mission president or a stake president may request approval from the Office of the First Presidency to baptize and confirm, ordain, or recommend missionary service for a child of a parent who has lived or is living in a same-gender relationship when he is satisfied by personal interviews that both of the following requirements are met:

- The child accepts and is committed to live the teachings and doctrine of the Church, and specifically disavows the practice of same-gender cohabitation and marriage.
- 2. The child is of legal age and does not live with a parent who has lived or currently lives in a same-gender cohabitation relationship or marriage.

The videos reveal clubby exchanges between the leaders, most of whom belong to the church's <u>Quorum of the Twelve Apostles</u> (the church's second-highest leadership body after the First Presidency), and Mormon politicians and other experts invited in to brief the apostles. In a <u>presentation</u> that has provoked some <u>criticism</u>, former Senator Gordon H. Smith, a Republican of Oregon, shared with the apostles that he voted in favor of the Iraq War partly because he believed it could open the region for Mormon missionaries.







In accordance with approved procedures, the annual General Authority base living allowance has been increased from \$116,400 to \$120,000. This will begin with your paycheck issued on January 10, 2014 (pay period 1).

LDS Church spokesman Eric Hawkins declined to confirm the salary numbers Monday, while defending the payment of full-time ecclesiastical leaders.

"General authorities leave their careers when they are called into full-time church service," Hawkins said in a statement. "When they do so, they focus all of their time on serving the church and are given a living allowance. The living allowance is uniform for all general authorities [including First Presidency, Quorum of the Twelve Apostles, First and Second Quorums of the Seventy and Presiding Bishopric]."

No funds for this "living allowance," the spokesman said, "come from the tithing of church members but instead from proceeds of the church's financial investments."




